BY-LAWS

As approved by the
Grand Chapter of the Commonwealth of Virginia
January 7, 2003

Article I: The Stated Convocation of Mount Vernon Chapter No 14, ROYAL ARCH MASONS, shall be held at the George Washington Masonic National Memorial, Alexandria, Virginia on the FIRST TUESDAY of each month at 7:30 PM o'clock.

Article II: Every member of the Chapter except the High Priest, Treasurer, Secretary, Tiler and Life Members in Perpetuity shall be charged by the Secretary with the sum of Thirty-five Dollars (\$35.00) PLUS Grand Chapter Dues and Assessments, as Annual Dues. Dues are payable on or before the beginning of the capitular year.

Article III: The fees in this Chapter shall be One Hundred Dollars (\$100.00), of which amount Twenty-five Dollars (\$25.00) shall accompany the petition.

Article IV: The Treasurer shall receive an annual honorarium of Three Hundred Dollars (\$300.00), payable in annual installment.

Article V: The Secretary shall receive an annual honorarium of Six Hundred Dollars (\$600.00), payable in annual installment.

Article VI: The Tiler or Acting Tiler shall receive an honorarium of Five Dollars (\$5.00), for each convocation he attends in that capacity.

Article VII. The Three (3) TRUSTEES who have been recommended by the Chapter and appointed by the Court having jurisdiction, shall at each annual convocation in September make a report of the investment of the funds and condition of property entrusted to their care.

Article VIII: Any amendment proposed to these By-laws must be submitted in writing at a Stated Convocation, lie over one month. The membership shall be notified and adoption shall require a Two-thirds majority, Affirmative vote of the members present for its adoption.
