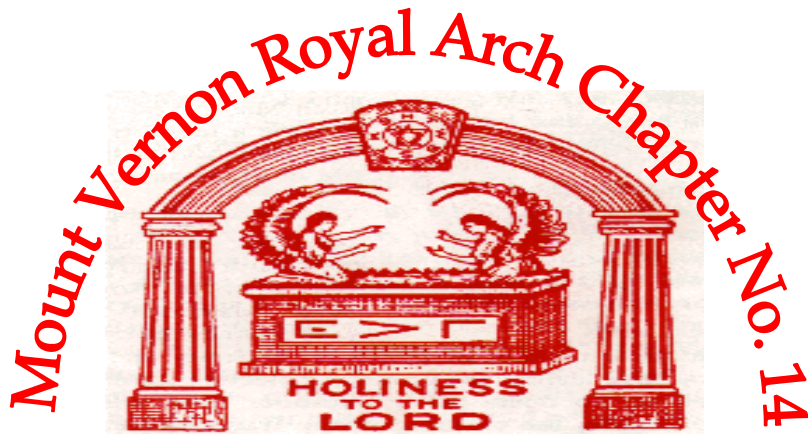

Companions,

If you remember, in my first Trestle Board I said that we would have to look at the financial status of the Chapter and decide on a course of action on the financial well being of the Chapter. The Executive Committee and myself met last month and proposed a By-Laws change to increase the dues as being necessary. We informed the members at the March meeting of this proposal and now request your input. The proposed change to the By-Laws are: **Now** "Every member of the Chapter except the High Priest, Treasurer, Secretary, Tiler and Life Member in Perpetuity shall be charged by the Secretary with the sum of Sixteen (\$16.00) PLUS Grand Chapter Dues and Assessments as Annual dues. Dues are payable on or before the beginning of the capitular year." **NEW** "Every member of the Chapter except the High Priest, Treasurer, Secretary, Tiler and Life Member in Perpetuity shall be charged by the Secretary with the sum of Thirty-Five (\$35.00) PLUS Grand Chapter Dues and Assessments as Annual dues. Dues are payable on or before the beginning of the capitular year." This was not an easy choice, but, it is necessary for the continued success of the Chapter. We will vote on this at May meeting.
